Prof. Menicucci is a **Lawyer** registered with the

Bar of the Court of Salerno since 2004. Furthermore, he was Member of the Academic Board of the Ph.D. programme in International Law and Domestic Law in International Matters at the University of Salerno, from the XV to the XVIII cycle; Member of the Academic Board of the PhD programme in Legal Sciences of the University of Salerno, XIX cycle. He visited the offices of BAFIN (*Bundesanstalt für Finanzdienstleistungsaufsicht* - Federal Financial Supervisory Authority) in Frankfurt/Bonn, carrying out study and research activities, invited Dr. Johannes Engels on 2.11.2013, the Court of Justice of the European Union in Luxembourg, invited by Judge Jose Da Cruz Vilaça from 4 – 7.04.2016, and The International Tribunal for the Law of the Sea in Hamburg, invited by Judge Ida Caracciolo, from 13-15.09.2023.

He is **Ordinary Member of AIDIM (Italian Association of Maritime Law)**, Roman Regional Committee since 15.02.2016; Member of the research group SARUMS (Safety and Regulations for European Unmanned Maritime Systems), founded by EDA (European Defence Agency) since 01.12.2020.
