##### 1. Margins

Top 2,5 cm

Right 3 cm

##### 2. Text

Chapters' titles: **Times New Roman** - 14 – Left aligned - **Bold**

Paragraphs' titles (I Level): Times New Roman - 12 - Justified – **Bold** (do not insert any full stop mark after the title of the paragraph)

Sub-paragraphs' titles (II Level): Times New Roman - 12 - Justified – **Bold Italic**

Further Sub-paragraphs' titles (III Level): Times New Roman - 12 - Justified - *Italic*

Main text: Times New Roman - 12 - Justified - Regular - Indent, first line by 0,7 cm –Single line spacing

NOTE:

**The maximum length allowed for the paper is 8,000 words (around 12 pages, footnotes included)**

Footnotes: Times New Roman - 10 - Justified - Regular (in the main text, the footnote number shall be placed before any punctuation, but after brackets).

E.g.. ...the display of religious garments, even in public venues<sup>2</sup>.

Page numbers: Times New Roman - 10 – Bottom, Right – Regular

Summary title: Times New Roman - 10 - Justified - SMALL CAPS

Summary text: Times New Roman - 10 - Justified - Regular

E.g. CONTENTS: 1. Introduction. – 2. Etc.

### 4. Abstract & Keywords

Title: Times New Roman - 12 – left-aligned – **Bold** – indent: 0,7 cm

Text: Times New Roman - 12 - Justified – *Italic*

NOTE:

The abstract shall count maximum 250 words

Keywords shall be not more than 5 (five)

#### **Abstract**

*The recent proliferation of the normative framework to prevent and punish transnational crimes has highlighted the importance (and autonomy) of the rule of law principle in the 21st century, especially in its substantial dimension, i.e., the adequate protection of human rights and the State's compliance with its international obligations to respect, protect, and fulfil individual guarantees. In this chapter, we focus on the state of the art in the European scenario, emphasizing the need to ensure more effective individual rights in the fight against transnational crime.*

## 5. Cross or previous references

In the case of consecutive reference of the same work or document, use "*Id.*", possibly followed by the indication of the *specific* paragraph or page (e.g., *Id.*, para. 6). In the case of a work already mentioned, please, use "*supra*", followed, where possible, by the indication of the *specific* paragraph or page (e.g., ORIOLO, *supra*, at 112). If you have cited more than one work by the same author, use a form of the title that is as abbreviated as possible (e.g., ORIOLO, *La responsabilità, supra*, at 112).

Other:

- acronyms must be typed without any punctuation in them (UN and not U.N)

## 6. Peculiar elements of the text

### Quotation marks

Use in the text low quotation marks (« »). Do refrain from using the high quotation marks (“”) or to type low quotation marks with a double greater/less symbol (<< >>)

E.g.:

- the tool indicated as «negotiated crisis agreement».

Should a quoted text present other quotation marks in it, make sure to change them in high quotation marks (“”) and, if needed for another layer of quotations, single quotation marks (‘’)

- as the author says: «there’s a lack of “measured” tools depending on a company’s needs».

### USE OF ITALIC

*Italic* shall be used:

- for foreign words, especially in Latin (see *infra*);
- in the referencing of volumes, books, chapters in volumes, articles in journals, etc. (see Section 3);
- in the caselaw’s name of parties referred to (see Section 1);
- to give emphasis to specific words or ideas, in this case use *Italic* parsimoniously

### LATIN OR FOREIGN WORDS

LATIN OR FOREIGN WORDS shall be rendered in *Italic*, do not use any quotation mark to these words (except if there’s an actual quote).

- The code included a broad concept of *vivre ensemble*.

### ADDITIONAL QUOTATION RULES

The text in quotations shall be rendered in Regular (not *Italic*).

## 7. Other

- Do **not** insert any **full stop mark** after the **titles** of the chapter or of any paragraph/subpara.
- **N dash** (–) in the text can be used as an alternatives to commas or brackets for parenthetical elements or for listing items.
- **Hyphen** (-) shall be used in articles (e.g.: art. 416-*bis* c.p.) and number ranges (160-163)
- A footnote referring to an author or caselaw can directly start with the proper reference, without resorting to use “See” or Cfr”.
- For **cross-references** in your own chapter or to other chapters of the volume, do refer to the Section and not to the page number since the latter is subject to change in the drafting process.
