ANNA ORIOLO, Scientific Coordinator of the EU-GLOBACT Project, is Associate Professor of International Law and of European Union Law and European and International Criminal Law at the Department of Legal Sciences, University of Salerno. She is Founder and Director of the *International and European Criminal Law on Cultural Issues, Human Rights, and Security* (IECLO), based at the same University, where she is also Lecturer in Institutions of International Law and *Diplomatic and Consular Law* at the Department of Business Sciences - Management and Innovation Systems (DISAMIS). She has also been Lecturer in International Law and European Union Law at the University of Cagliari, at the Université Lumiere Lyon 2, at the School of Specialisation for Legal Professions at the University of Salerno and Visiting Professor at the University of Salerno (2006-2024) and her works (in Italian, English and French) covers a wide range of topics in the field of international and EU law, e.g. international criminal law, transnational crime *and core international crimes*, human rights and fundamental freedoms, *cross-fertilisation*, cybersecurity, environmental and water protection, global law and policies, cultural heritage, ethics in international and EU law, corporate social responsibility.

BIOGRAPHY

VIRGINIE MERCIER is a Full Professor of *Droit privé* and Member of the *Centre de droit économique*, at the Faculty of Law and Political Science of the University of Aix-Marseille (France) where she directs *the Institut de Droit de l'Environnement et du Développement Durable* (IDEDD) and the *Master Droit de la banque et des operation patrimoniale*. She recently won a selection for *Visiting Researcher* at the Department of Legal Sciences (School of Law) of the University of Salerno. Prof. Mercier's research activity focuses on environmental law, obligations and liability of entities arising from environmental law, corporate social responsibility, and civil liability in connection with environmental law and sustainable development. Her international academic activities include cooperation with the *Centre de droit des affaires et du commerce international* of the University of Montreal (Canada): in connection with this partnership, she directs the *Summer School Gouvernance environnementale et sociétale de l'entreprise - Approche européenne*. Prof. Mercier is Member of the *Advisory Board* of the multidisciplinary legal observatory IECLO (*International Crime and EU Law*), co-funded by the European Commission (2023-2026) at the Department of Legal Sciences (School of Law) of the University of Salerno.

TITLE

Corporate Social Responsibility, Transnational Crime and Due Diligence for a Sustainable Development

ABSTRACT

The EU is developing corporate sustainability policies for companies with the aim of strengthening the protection of the environment and human rights in the EU and around the world. On 23 February 2022, the Commission presented to the European Parliament and the Council a proposal for a Directive on corporate sustainability due diligence and amending Directive (EU) 2019/19371. The proposed Directive, based on arts. 50 and 114 TFEU, lays down obligations with respect to adverse impacts on human rights and adverse environmental impacts, whether actual or potential, incumbent on companies in the context of their activities, the activities of their subsidiaries and the activities in the value chain carried out by entities with which the company has an established business relationship. It also lays down rules on liability in the event of a breach of these obligations. On 14 December 2023, the Council and Parliament reached a provisional agreement on the directive, defining its scope and clarifying the responsibilities of non-compliant companies, better defines the various penalties and completes the list of rights and prohibitions that companies should comply with. The directive was finally approved last June 2024. The result is a compromise text that has narrowed the contours of the supervisory obligation resulting from the December 2023 agreement.

<u>When Corporate Responsibility Turns into State Responsibility: Gender Discrimination against LGBTIQ People in the</u> <u>Case Hungary vs Netflix</u>

ABSTRACT

In the light of the definition of Corporate Social Responsibility as a set of behaviors, practices and activities whereby companies integrate social and environmental concerns into their business operations, the speech aims to highlight how corporate self-regulation practices can sometimes interact in a challenging way, if not even conflict, with a national legal system in a given historical moment, especially in presence of laws that express a peculiar political system. Such an interaction takes on an even more complex dimension with reference to Media & Entertainment Companies, since these, unlike all other corporations, spread and convey messages to an indistinct mass of recipients. The Case under analysis offers the opportunity to reflect on the possible scenarios where the State decides to repress Corporate Social activities carried out by a multinational company or, on the contrary, promotes or endorses practices that are harmful to rights of general interest.

TITLE

Criminal Liability of Companies for Environmental Crimes

ABSTRACT

The industrialization process that took place after the industrial revolution and the rapid advancement of technology have led to an uncontrollable increase in environmental pollution and irreversible destruction of the ecosystem and biodiversity. With the realization of these environmental problems as a threat since the 1970s, the importance given to the fields of environmental law and environmental criminal law has increased and necessary steps have been taken to prevent the climate crisis that has grown with environmental problems and to protect the environment. One of these steps is the adoption of the concept of ecocide and the efforts made to make it a valid crime type in international law. In this presentation, firstly, the philosophical approaches to environmental protection will be briefly mentioned and ecocide as an environmental crime will be analyzed. Then, the criminal liability of companies with legal personality, which is the main subject of the presentation, will be discussed in the context of the crime of ecocide.
